

- t. The sale certificate shall be issued after receipt of entire sale consideration and confirmation of sale by secured creditor. The sale certificate shall be issued in the name of the successful bidder only. No request for change of name in the sale certificate other than the person who submitted the bid/participated in the auction will be entertained.
- u. The properties brought under auction sale are secured assets of the Bank and no cases are pending against the SARFAESI measures initiated by the Bank as per the knowledge of the Authorised Officer. However, any subsequent litigations initiated against the SARFAESI sale, such sale shall be subject to outcome of the final order of the court/tribunal. Pendency of such cases cannot be a valid ground for refunding/cancelling the auction sale already completed. The intending bidder shall abide by the terms & conditions of the sale as envisaged under Security Interest (Enforcement) Rules, 2002.
- v.
